

Summary

Recreation and Conservation Office staff requests a decision from the Recreation and Conservation Funding Board that will adjust the funding allocations for the Washington Wildlife and Recreation Program – State and Local Parks categories.

Background

At the October 26, 2016 meeting, the Recreation and Conservation Funding Board (board) adopted policy related to the implementation of Senate Substitute Bill (SSB) 6227, which establishes new funding percentages for acquisition and development in the Washington Wildlife and Recreation Program (WWRP) - State Parks and Local Parks categories. See Item 5A and Item 5B of the <u>October 2016 materials</u> for more information.

The Legislature requires that 'no less than 40 percent and no more than 50 percent of funding allocation shall go to acquisition costs' in both of these two categories, leaving the board with some discretion on implementation between the 40-50 percent range. In creating the project funding lists for 2017-19, staff identified unforeseen consequences resulting from the board's new policy of leaving no partially-funded acquisitions, which places constraints on project funding. For this purpose, staff requests a modification to the existing policies.

There are two major concerns with implementation of the new board policy for these two WWRP categories:

- At various funding levels, the percent of acquisition either falls below 40 percent or above 50 percent and violates state law.
- Implementing the new board policy requires RCO to manually create the list, rather than having it be automated, leaving it less transparent and predictable to the Legislature, stakeholders, and the public.

State Parks Category

In the State Parks category, the policy adopted is to: "Fund acquisition costs up to 50 percent, but fund no partially-funded acquisition projects. The remainder of funds go to development costs."

When there is a partially-funded acquisition project in this category, funds are pulled from that acquisition and put into the next development project or projects on the list (which may or may not be partially-funded).

While the policy is implementable at many funding levels, there are numerous other funding levels where the acquisition costs fall below 40 percent and we violate the existing statute. On the current list, this situation is best illustrated at the \$40 million level (Table 1); however, it occurs at multiple funding levels between \$40 and \$100 million.

Local Parks Category

In the Local Parks category, the policy adopted essentially works in the reverse of the State Parks policy, whereby the direction is: "Fund acquisition costs at 40 percent and development costs at 60 percent, but fully fund any partially-funded acquisition projects or project costs."

When there is a partially-funded acquisition project in this category, funds are pulled from the lowestranking development project or projects (which may or may not be partially-funded) and put into that partially-funded acquisition project.

Again, while the policy is implementable at many funding levels, there are multiple funding levels where acquisition costs rise above 50 percent and we violate the existing statute. On the current list, this situation is best illustrated at the \$40 million level (Table 2).

Staff Recommendation

Staff recommends the following:

- Fund the State Parks category at 50 percent acquisition costs and 50 percent development costs 1) to accomplish the goals and needs of the Washington State Parks and Recreation Commission and their stakeholders and 2) to enable the Legislature to fully understand what it is they would be funding in the final budget bill.
- Fund the Local Parks category at 40 percent acquisition costs and 60 percent development costs
 1) to accomplish the goals and needs of the local parks community and 2) to enable the Legislature to fully understand what it is they would be funding in the final budget bill.
- Per board decision in October 2016, revisit this new policy on an as-needed basis.

Next Steps

If adopted by the board, the new funding formulas will be immediately applied to the WWRP – State Parks and Local Parks ranked lists.

Recreation and Conservation Funding Board Members:

It is intended that this summary be used with the materials provided in advance of the meeting. The Recreation and Conservation Office (RCO) retains a recording as the formal record of the Recreation and Conservation Funding Board (board) meeting.

Call to Order

Chair Willhite called the meeting to order at 1:00 p.m. Staff called roll and a quorum was determined. Member Milliern was excused.

Item 1: Washington Wildlife and Recreation Program: Funding Allocation in the State Parks and Local Parks Category

Director Cottingham explained the purpose for convening this special meeting of the board. At the October 26, 2016 meeting, the Recreation and Conservation Funding Board (board) adopted policy related to the implementation of Senate Substitute Bill (SSB) 6227, which establishes new funding percentages for acquisition and development in the Washington Wildlife and Recreation Program (WWRP) - State Parks and Local Parks categories.

Wendy Brown, RCO Policy Director, explained that the Legislature requires that 'no less than 40 percent and no more than 50 percent of funding allocation shall go to acquisition costs' in both of these two categories, leaving the board with some discretion on implementation between the 40-50 percent range. In creating the project funding lists for 2017-19, staff identified unforeseen consequences resulting from the board's new policy of leaving no partially-funded acquisitions, which places constraints on project funding.

She explained the two major concerns with implementation of the new board policy for these two WWRP categories:

- At various funding levels, the percent of acquisition either falls below 40 percent or above 50 percent and would thus violate state law.
- Implementing the new board policy requires RCO to manually create the list, rather than having it be automated, leaving it less transparent and predictable to the Legislature, stakeholders, and the public.

Staff proposed the following solutions for board consideration:

• Fund the State Parks category at 50 percent acquisition costs and 50 percent development costs. This would: 1) accomplish the goals and needs of the Washington State Parks and Recreation

Commission and their stakeholders and 2) enable the Legislature to fully understand what it is they would be funding in the final budget bill.

- Fund the Local Parks category at 40 percent acquisition costs and 60 percent development costs. This would: 1) accomplish the goals and needs of the local parks community and 2) enable the Legislature to fully understand what it is they would be funding in the final budget bill.
- Per board decision in October 2016, revisit this new policy on an as-needed basis.

Public Comment

Joan Fleming, Backcountry Horsemen of Washington, shared that her organization supports the new changes proposed.

Board Discussion

Member Stohr opened a discussion about combination acquisition and development projects. Brent Hedden explained that RCO views the project portions separately to align with the policies for each type of project funding.

Member Shiosaki asked about potential consequences should the board reverse the policy and adopt the proposed changes, specifically with regard to partially funded projects. Director Cottingham and Member Herzog explained that State Parks was concerned about partially funded projects with phased acquisitions, but have since learned to work with landowners to accomplish their project goals and needs.

Member Bloomfield stated that the resolution includes language to revisit the policy, which maintains flexibility and allows for adjustment should future issues arise.

Member Mayer expressed concerns about maintaining transparency between state agencies, referencing the thresholds of acquisition and development. Member Deller agreed; he shared his support of new changes.

Member Willhite acknowledged that the changes meet the legislative intent of the WWRP statute, fairly allocates resources, allows for flexibility, and addresses concerns regarding transparency and balancing acquisition and development funding.
