

Mileage for Heavy-Duty Vehicles

Below are the rules for being reimbursed when using heavy-duty vehicles to transport equipment to a worksite.

Reimbursable Costs

RCO will honor the rate in the Washington State Department of Natural Resources' and Washington Fire Chiefs' *Wage & Equipment Rate Guide* that was in place when the use of heavy-duty vehicle occurred.

Please review the section titled "Transportation Vehicles with Operator." NOTE: RCO treats the operator rate and mileage rate separately. The "Daily Wet Rate-\$400" is not applicable.

When billing for this cost, include a description with the following elements:

- Vehicle Type: Pick the specific type of vehicle that matches the list, such as "full size truck."
- Mileage rate: Identify the mileage rate used from the list.
- Miles driven: Identify the miles driven.
