By board policy, 45 percent of the funds in this category must be for local agency, Native American tribes, nonprofits, and salmon recovery lead entity projects; 45 percent for state agency projects; and remaining 10 percent to fully fund partially funded local, Native American tribe, nonprofit, and lead entity projects, and then state projects. Any remaining would go to next highest ranked projects.
