Port of Everett

Grant Requested: \$1,000,000

Renovating the 10th Street Boat Launch

The Port of Everett will use this grant to renovate the 10th Street Boat Launch, the largest boat launch in the state, which serves more than thirty-five thousand boats during peak years. The Port will install boarding floats for twelve launch lanes and upgrade composite siding, cleats, hinges, hinge covers, abutment plates, and bumpers. Des Moines

Grant Requested: \$348,750

Upgrading Boarding Floats at Redondo Beach Park

The City of Des Moines will use this grant to upgrade the float string at the Redondo Beach Park boat launch ramp, which was installed in 1980 and has degraded to the point of failure by rot and marine borers. The City will replace the creosote timber and concrete approach wedge that anchors the north boarding float string with one that will be accessible to people with disabilities. Grant Requested: \$200,000

Planning the Redevelopment of North Cove Marina

The City of Lake Stevens will use this grant to design and permit the redevelopment of North Cove Marina at Lake Stevens, the largest lake in Snohomish County. The City plans to conduct outreach and then modernize the facility and replace the dilapidated docks at the boat launch. Grant Requested: \$262,500

Replacing Boarding Floats at Possession Beach Waterfront

The Port of South Whidbey will use this grant to replace six deteriorating boarding floats at its most used boat ramp on south Whidbey Island. The floats were built in 1987 with heavy timber and Styrofoam floatation and are deteriorating, creating a potential safety and environmental issue. Replacement floats will consist of light-permeable surfaces and non-slip decking, reducing the risk of injury. Port of Grays Harbor Renovating the Friends Landing Boat Launch

Grant Requested: \$650,000

The Port of Grays Harbor will use this grant to renovate the upland boat launch amenities at Friends Landing on the Chehalis River, to make it safer and easier to access. The Port will pave the boat launch parking lot and repave the entryway, build a loading ramp and parking spaces for people with disabilities, add more than three hundred feet of paths around the parking lot, update the parking and safety lines for pedestrians, and install a payment station, information kiosk, and a portable restroom, all of which will accommodate people with disabilities. Everett Renovating Langus Riverfront Park Boat Launch

Grant Requested: \$592,800

The City of Everett will use this grant to renovate the Langus Riverfront Park boat launch in Snohomish County. The launch is protected by a debris deflector system consisting of timber piles attached to floating timber logs; however, the system is failing and large woody debris is getting through. The City will replace the boarding floats, the old timber piles with steel pilings, and the failing debris deflectors with high-density ones. Lakewood Improving Access and Safety on Lake Steilacoom

Grant Requested: \$1,000,000

The City of Lakewood will use this grant to improve safety and boater access on Lake Steilacoom in Edgewater Park, the second largest lake in the city and the only public access to the lake. The City will build a floating dock to support launch use, a picnic shelter, site furnishings, and a restroom. On the south end of the park, it will build a motorized boat launch and parking. In addition, the City will remove invasive plants and plant native plants to improve habitat and stormwater function. Mukilteo Replacing Boat Launch Floats in Lighthouse Park

Grant Requested: \$620,021

The City of Mukilteo will use this grant to replace the north and south floating docks at the Lighthouse Park boat launch in Snohomish County. The boat launch is heavily used, with an average of thirty-five hundred boat launch parking permits issued a year. The existing floating docks have rusted and worn out and have become waterlogged and rotten due to age and exposure. The City will replace them with ones that require limited maintenance. Washington Department of Fish and Wildlife **Grant Requested: \$890,000**
Redeveloping the Ohop Lake Water Access Area

The Department of Fish and Wildlife will use this grant to redevelop the boat launch area at the Ohop Lake Water Access Area in Pierce County. The department will design and build a single boat ramp and boarding float and install a modular concrete restroom. It also will make it easier for people with disabilities to access and use the boat ramp by installing a loading platform and paved parking area, including a paved path from the restroom to the new loading platform. Washington State Parks and Recreation Commission **Grant Requested: \$880,000**
Redeveloping the Lake Sammamish Boat Launch

State Parks will use this grant to design, permit, and plan the redevelopment of the Lake Sammamish boat launch, which is used by about fifty thousand vehicles a year. The planning and design work will include removal and replacement of a damaged boat ramp, floats (existing steel pile will remain), and restroom, and stormwater mitigation if needed. Washington State Parks and Recreation Commission **Grant Requested: \$2,640,000**
Replacing Moorage Floats at Twenty-Five Mile Creek State Park

State Parks will use this grant to upgrade outdated boat launch facilities at the westernmost launch in Twenty-Five Mile Creek State Park. The ten guest moorage floats are in disrepair; the wood decking is deteriorating and splitting apart, and the metal framework has become exposed, creating safety hazards that have resulted in frequent dock closures. Updating Restrooms and Parking at Four Boating Facilities

The Department of Fish and Wildlife will use this grant to improve boating facilities at Evergreen Reservoir, Lind Coulee Island, Heart Lake, and Windmill Lake by replacing the restrooms and parking pads with ones that are easier to use and access for people with disabilities. Washington Department of Fish and Wildlife **Grant Requested: \$990,000**
Improving Accessibility at the Spencer Lake Water Access Site

The Department of Fish and Wildlife will use this grant to improve the Spencer Lake Water Access site in Mason County. The department will pave the entrance and parking lot, replace the boat ramp with one that is accessible to people with disabilities, install a concrete restroom, and build a pedestrian pathway between the restroom and boarding float and launch area. The new parking area will be paved and graded to direct surface water toward the outside edge of the property where a buffer of native plants will filter the water. A curb that will provide shoreline protection, reduce erosion, and create a partition from the pavement to the shoreline where anglers and visitors can recreate safely away from vehicles. Washington State Parks and Recreation Commission **Grant Requested: \$2,120,000**
Improving the Lake Wenatchee Boat Launch

State Parks will use this grant to improve the boat launch on Lake Wenatchee. As the only formal public boat launch on the lake, it's very popular and there often are significant backups at the single-lane ramp. The overflow parking usually is at capacity and lacks designated parking spots. State Parks will build a boat ramp and boarding floats, pave and stripe the overflow parking area, and create a pedestrian path that connects the boat launch area to the day-use restroom. Washington Department of Fish and Wildlife **Grant Requested: \$2,400,000**
Developing Access to Chapman Lake

The Department of Fish and Wildlife will use this grant to develop motorized boating access on Chapman lake in Spokane County, one of only two lakes in the area that provides anglers an opportunity to catch kokanee salmon. The department will install a concrete plank boat ramp and a toilet, pave the parking lot, and add a parking pad and staging area for people with disabilities. Washington State Parks and Recreation Commission **Grant Requested: \$2,530,000**
Improving Sacajawea State Park Moorage and Facilities
