U.S. Forest Service, Mount Baker-Snoqualmie National Forest Caring for the Mountain Loop Scenic Byway Grant Requested: \$200,000

The Darrington Ranger District will use this grant to pay for up to four seasonal employees for two years to maintain twenty-one trailheads, multiple day-use areas, and hundreds of dispersed campsites along the Mountain Loop Scenic Byway. The byway annually receives more than 230,000 outdoor enthusiasts visiting the South Fork Stillaguamish and Sauk River valleys. The combination of hard and easy hikes, high mountain lakes, stunning vistas, and unique natural features has long made this a favorite with the Seattle and Everett communities. Visitors enjoy the byway for many activities including hiking, backpacking, picnicking, camping, hunting, fishing, rock climbing, scenic driving, snowshoeing, and cross-country skiing. The Mountain Loop Byway stands apart in the region with areas of unpaved mountainside camping and some of the most stunning and remote backcountry experiences one can offer close to cities. Grant Requested: \$186,000

U.S. Forest Service, Olympic National Forest Maintaining the Olympic Forest Front Country

The Olympic National Forest will use this grant to pay for volunteers, contractors, partners, and up to three interns to maintain sixteen campgrounds, seventy-seven trailheads, three rental cabins, numerous dispersed camping and day-use sites, and two boat launches in Mason County. Crews will remove dangerous trees, clean up trash and dump sites, collect fees, clean restrooms, install signs and bulletin boards, repair facilities and parking lots, and maintain picnic tables and fire rings. The Lake Quinault area is a popular day hiking and camping destination and provides a broad range of other recreation opportunities, including hunting, fishing, recreational shooting, sightseeing, boating, and more. U.S. Forest Service, Okanogan-Wenatchee National Forest Maintaining the Cle Elum Front Country Grant Requested: \$145,000

The Cle Elum Ranger District will use this grant to pay for two interns, contractors, partners, and two employees to maintain seventeen campgrounds, thirty trailheads, four-hundred dispersed camping and day-use sites, five boat launches, and two rental cabins in Kittitas County. Crews will remove dangerous trees, clean up trash and dump sites, collect fees, clean restrooms, install signs and bulletin boards, repair facilities and parking lots, and maintain picnic tables and fire rings. The closeness to Puget Sound, coupled with a diverse array of outdoor recreation

opportunities, brings hundreds of thousands of summer visitors to the district. This work will provide upkeep and basic operation of these high-use sites, protect natural areas next to recreation sites, and prevent degradation of areas critical to threatened and endangered species, such as spotted owls and bull trout. U.S. Forest Service, Mount Baker-Snoqualmie National Forest Maintaining the Snoqualmie Front Country Grant Requested: \$200,000

The Snoqualmie Ranger District will use this grant to support seasonal staff for two years to maintain more than fifty trailheads, eight campgrounds, and hundreds of dispersed campsites used by more than 500,000 visitors annually. The crews will maintain trailheads, repair facilities, mitigate hazards, repair vandalism, and clean campsites. Throughout the year, visitors from the Seattle area flock to the district for hiking, horseback riding, camping, off-road vehicle riding, recreational target shooting, hunting and fishing, and climbing. U.S. Forest Service, Okanogan-Wenatchee National Forest Maintaining Methow Valley Recreation Areas Grant Requested: \$199,020

The Methow Valley Ranger District will use this grant to maintain twenty-five campgrounds, thirty trailheads, two picnic areas, and the Washington Pass Scenic Overlook. Crews will clean toilets and campsites, control noxious weeds and remove dangerous trees, maintain water systems, mow, provide visitor information, collect fees, provide security patrols, collect garbage, and repair picnic tables, fire grates, and bulletin boards. The area has long attracted recreationists to its variety of habitats, from river valleys to mountain passes, to flowery meadows high on the Pacific Crest. U.S. Forest Service, Okanogan-Wenatchee National Forest Maintaining Wenatchee River Recreation Areas Grant Requested: \$124,000

The Wenatchee River Ranger District will use this grant to fund a crew to maintain trailheads, campgrounds, day-use sites, and dispersed recreation sites in Chelan County. Crews will remove trash, maintain restrooms and bulletin boards, remove dangerous trees, and clean campsites, day-use areas, and trailheads. The Wenatchee River Ranger District sees more than one million visits annually to its twenty-six campgrounds, fifty-six trailheads, and more than three-hundred dispersed recreation sites. U.S. Forest Service, Mount Baker-Snoqualmie National Forest Maintaining Highway 2 Trails and Campsites Grant Requested: \$200,000

The Skykomish Ranger District will use the grant to fund a crew to maintain recreation facilities in King and Snohomish Counties. The crew will clean twelve vault toilets, pick up trash, clean campsites, and maintain twenty-five trailheads. There are nearly 300 dispersed campsites that serve more than 200,000 hikers, equestrians, campers, climbers, kayakers, rafters, anglers, and hunters. This project will prevent further damage to sensitive streamside areas, wetlands, and stream habitats while providing a safe recreational experience to the public. U.S. Forest Service, Okanogan-Wenatchee National Forest Renting Portable Restrooms Grant Requested: \$33,400

The Cle Elum Ranger District will use this grant to rent portable toilets to be placed in high-use dispersed camping areas from Memorial Day to Labor Day. Dispersed camping takes place outside of formally constructed campgrounds. These campsites are created by campers, not planned by the Forest Service, and do not usually include amenities such as toilets. Providing sanitation in areas with very heavy recreational use will reduce public health hazards and protect ecologically sensitive steam banks and streams used by species listed under the federal Endangered Species Act, such as bull trout. Grant Requested: \$150,000

U.S. Forest Service, Colville National Forest Caring for the Colville National Forest Facilities

The Colville National Forest will use this grant to hire seasonal employees to maintain forty-two campgrounds, ninety-two developed recreation sites and trailheads, and 830 dispersed campsites scattered across the forest. The crews will remove trash, clean toilets, identify and remove dangerous trees, treat noxious weeds, repair water systems, and fix or replace picnic tables, fire rings, signs, and information boards. The Colville National Forest lies just fifty miles from Spokane, the second largest city in Washington, and contains parts of the Pacific Northwest National Scenic Trail and the International Selkirk Loop, which attract many visitors. Washington State Department of Natural Resources Grant Requested: \$193,150 Maintaining Capitol and Yacolt Burn State Forests

The Department of Natural Resources will use this grant to maintain twelve campgrounds, eighteen trailheads, fifty-three restrooms, and three miles of trail, and facilities in the Capitol and Yacolt Burn State Forests near Olympia and Vancouver, respectively, as well as other recreation facilities in the department's Pacific Cascade Region. Crews will clean restrooms, repair facilities, pump vault toilets, remove litter, and maintain the McLane Creek interpretive nature trails. Washington Department of Natural Resources Cleaning South Puget Sound Facilities

The Department of Natural Resources will use this grant to hire a crew to clean and maintain forty-seven restrooms in the Green Mountain, Tahuya, Hood Canal, Elbe Hills, Tahoma, Tiger Mountain and Raging River State Forests, as well as the Middle Fork Snoqualmie and West Tiger Mountain Natural Resource Conservation Areas in the busy South Puget Sound region. Routine cleaning will reduce long-term maintenance costs and potentially decrease vandalism that frequently occurs in the facilities. Staff will maintain twenty-one toilets, 187 campsites, six day-use areas and trailheads, and dispersed recreation areas in three, department-owned blocks of land. From April to October about 60,000 visitors use the recreation sites. The Thurston County Public Works Department will use this grant to repair footbridges and stairways in Burfoot Park, a 60-acre regional park that offers breathtaking views of Puget Sound and the Budd Inlet. The park's infrastructure is aging and deteriorating due to extensive use and exposure to wet weather conditions, creating safety issues. The crew will repair deteriorated tables, bent fire ring grills, broken bulletin boards, and uprooted bollards, and preserve site markers, paint signs and bathrooms, and fix parking area delineators. An estimated 147,840 people recreate at the sites, participating in a range of activities including camping, hiking, picnicking, boating, wildlife viewing, and fishing. The Snoqualmie Ranger District will use this grant to fund trail crews, contractors, and coordination of volunteer groups to maintain 507 miles of trails for two years. Crews will remove fallen trees and overgrown brush, fix drainage structures, repair bridges, restore slide areas, remove boulders, and improve trail surfaces. The bulldozer will replace one purchased in 2005, which now costs thousands of dollars to repair each year. The motorsports complex is in the Airway Heights Off Road Vehicle Park, in Spokane County. The facility offers a closed-course competition motocross track that is full of jumps, bumps, and berms. The facility is open for practice four days a week from about April 1 to November 1, providing more days of use per week than any other track in the state. There are also twenty-four racing events hosted there every season. Maintaining this heavily used facility includes daily grading and bi-weekly deep grooming of the track along with regular watering, removing rocks from the track, screening dirt, and repairing track features. Track maintenance is done primarily with a bulldozer and is critical for the safety and enjoyment of the riders who use the course. Ferry County Parks and Recreation District 2 Improving the ORV Campground

The Ferry County Parks and Recreation District will use this grant to improve the fifty-one-acre ORV Campground off State Route 21, one mile south of Republic. The improvements will enhance the campground's infrastructure, safety, and amenities, creating a more accessible and

welcoming environment. The park district will improve the restroom building by insulating and repairing its interior and exterior, upgrading the well system, and replacing and modernizing plumbing, lighting, and electrical systems. The park district also will buy a tractor for ongoing park maintenance, install a small home as a permanent caretaker and campground host residence, add electrical hookups for six to eight campsites, and install Internet access equipment to provide coverage throughout the campground. In addition, the park district will put picnic tables in each campsite, grade and add gravel the main road and individual campsite access points, install outdoor and solar lighting to improve safety, and add signs and fencing around the campground.
